V. INTERNET COMMUNICATIONS

After much development, CGS unveiled its overhauled website non July 31. It features a refined look and greatly improves the user experience by automatically cross-posting content in multiple relevant areas. CGS's hundreds of newsletter articles, blog posts, press releases, op-eds, and news articles are now much more accessible.

Quantitative reporting of web traffic is widely recognized to be difficult. Three statistical packages report that the CGS website has received 109,000, 45,000 and 27,000 visits in the same recent month. All three packages suggest that the number of visitors to our site has been increasing by about 20% annually.

CGS's monthly electronic newsletter, *Genetic Crossroads*, goes to approximately 3500 subscribers; subscriptions have been growing at about 8% a year.

CGS's blog, *Biopolitical Times*, is included in the blog rolls of many other blogs addressing biotech and genetic topics. It is integrated into our website, making visitor traffic difficult to estimate. About three posts are made each week on the CGS blog.
